1. There are no refunds or credit for sponsorships once payment is received.
2. Logos must be submitted 3 weeks prior to the event being sponsored.
3. Logos must be submitted in a high-resolution format in .tif or .jpg to events@credaa.com
4. Logos will be used as submitted by sponsor. Any additions to the logo, such as name or contact information must be added to the logo file by the sponsor. CREDAА will not make additions or changes to the logo file received.
5. If a booth or table is part of you sponsorship package, the booth or table is to be used for handing out promotional materials only. The booth or table may not be moved or repositioned without the authorization of CREDAА. Booth and table assignments will be made by CREDAА.
